RE: Online Training

Through action taken by the MOST Board of Trustees, we are pleased to announce that online safety training will be available beginning September 15, 2015. Online training for the OSHA 10 will be provided by Red Vector and the OSHA 30 provided by Click Safety. MOST **WILL NOT** accept any other online training. Many of you will be familiar with this format as MOST is partnering with the Boilermakers National Apprenticeship Program and utilizing K-Learning who developed the BNAP's online training.

It is important to note that both online training programs use a generic OSHA Construction curriculum, whereas MOST's in-class training is geared directly to the Boilermaker Industry. Therefore, when a member completes the OSHA 30 online, they are meeting the guidelines of the Boilermakers Uniform Referral Standards and Joint Referral Rules, however, they are not completing the MOST Steel Erection (Subpart R) training, MOST Scaffolding User Class (Subpart L) and/or MOST Erector and Dismantler Class. If a jobsite is requiring that an individual completes additional Subpart R or Subpart L training, they may need to complete this training in class at the Local.

Requirements for the OSHA 10 online training are as follows:

- An applicant must be entered into MOST's database or have approval from their Local Lodge
- Must have never completed a MOST OSHA 10 or be within 6 months of their expiration date or must be a jobsite requirement where MOST is notified in advance by the Local Lodge

Requirements for the OSHA 30 online training are as follows:

- An applicant must be entered into MOST's database or have approval from their Local Lodge
- Must have never completed a MOST OSHA 30 or must be a jobsite requirement where MOST is notified in advance by the Local Lodge

Please note the Red Vector 10 Hour CAN NOT be used as a component of the Click Safety 30 hour. They are stand-alone classes and do not carry over like the MOST in-class training.

MOST will provide all approved applicants their username and password for them to login at the appropriate site. For anyone currently enrolled through the BNAP it is important to note that there will be two separate login credentials.

All online OSHA 10 hour and OSHA 30 hour completions will be displayed on the MOST Profiles, as well as each applicant's dashboard on the MBDS. Since the online OSHA 30 hour does not include the MOST Subpart R or MOST Subpart L, but does meet the requirements of the referral rules, you will now notice a check mark in these fields instead of a date. This would automatically update the OSHA 10 with a check mark as well. All in-class training for all MOST OSHA 30 hour components will still show a date.
