The OSHA 500 Train-the-Trainer course ***MUST BE TAKEN THROUGH MOST*** and is ***REQUIRED*** to teach all MOST Safety classes. It is important for all instructors to stay up to date and to take this course through MOST. Current instructors who are updating must have MOST 10 hour CS&H training.
